# **Review of the National Statistical System**



# Law of the Republic of Uzbekistan "On Official Statistics

Article 4.

**National Statistical System (NSS)** — a set of statistical bodies and other producers of official statistics (OS) that jointly produce and disseminate OS

#### NSS

Article 12

#### Major OS producers

Statistical bodies, headed by the authorized state body in the field of OS:

- Statistics Agency under the President of the Republic of Uzbekistan;
- Department of Statistics of the Republic of Karakalpakstan, regions and Tashkent city;
- district (city) statistics departments.

# Other OS producers

Government bodies included in statistical programs as producers of official statistics:

- Ministry of Economy and Finance;
- Ministry of Health;
- Ministry of Digital Technologies;
- Ministry of Agriculture,
- Minister of Ecology, Environmental Protection and Climate Change

- Central Bank;
- Tax Committee,
- Ministry of Internal Affairs;
- Ministry of Culture
- Ministry of Employment and Poverty Reduction

The Statistics Agency plays a central role in data management in the NSS. This role includes several key aspects that ensure the effective functioning and development of the country's NSS.

#### The Statistics Agency as an authorized state body in the field of OS:

Article 9

- implements state policy in the field of OS;
- coordinates activities on OS development issues within the NSS;
- implements priority areas of OS development together with other OS manufacturers;
- audits methodologies of other OS manufacturers for compliance with international recommendations;
- establishes the exchange of statistical data and metadata with OS manufacturers;
- develops measures for the coordinated distribution of OS within the NSS;
- develops a unified terminology in the field of OS in agreement with other OS manufacturers;

Article 11

- The Statistics Agency:

  coordinates the activities of other OS manufacturers within the framework of statistical programs
- based on the results of the audit, make mandatory representations when non-compliance with international recommendations is identified in the statistical methodologies of other OS manufacturers

#### The Statistics Agency has the right to:

Article 14.

> use and implement in the NSS modern methods and tools for collecting, processing, summarizing, analyzing, disseminating and storing statistical data;

#### The Statistics Agency:

Article 19

> together with other OS producers that are part of the NSS, ensures the implementation of statistical programs.

#### The main tasks of the Statistics Agency:

- > implementation of the policy and coordination of the development of official statistics in the NSS;
- development and implementation of statistical methodologies according to international standards;
- > **organization** of processes for collecting, processing and storing data to meet the needs of users;
- generation of reliable data according to international standards with mechanisms for increasing transparency;
- > wide application of digital technologies and integration with the systems of other data providers;
- > coordination of the formation and updating of the Open Data Portal of Uzbekistan;
- **development** and **implementation** of census measures at a high level;
- > improving the qualifications of NSS personnel and developing statistical research.




