Editorial Board

The Editorial Board (EB) comprises 40 Editors covering all the main statistical domains covered by Official Statistics and new domains, such as Data Science, Big Data and new Data Sources, Artificial intelligence and Machine Learning.

Temporary guest editors are nominated to manage Special Issues of the Journal.

Members of the EB are: Stephen Penneck, Vice President of the ISI and ex-President of the IAOS; Steve MacFeely, Chief Statistician OECD; Angela Me, Chief Research and Trend Analysis Branch, UNODC

Currently over 33% of the editors are women and almost 30% of them are from developing regions.


The Editors have two main roles;

- Organize the review process of the articles submitted to the Journal and ensure the quality of publication;
- Promote the Journal in relevant Conferences and at the same time search for high quality articles or propose Special Issues.

Some Statistics on the Journal

In 2023, the SJIOS published:

- 4 regular issues (Volume 39)
- 114 articles published, excluding editorials and discussion platform
- 1478 pages of content
- 46 articles were rejected


