To assess the level of poverty, the following criteria are used:

income used for consumption (DIP),

It includes consumer expenditures (excluding capital investments in production activities and savings) and the value (in monetary terms) of in-kind products of its own production and transfers.

When calculating the main indicators of poverty in Kazakhstan, an equivalence scale is used – 0.8 for every second and subsequent member of the household.

Income equivalence scale – correction factors that correct for required per capita income levels income in various sizes families. Take into account cost savings at the cost the effect of cohabitation. Shkala equivalence is 0.8 for the second and subsequent members of the household.

- ✓ development pilot IMB: spring-summer 2022
- ✓ current version work
 - ✓ Clarification of deprivation thresholds based on indicators of satisfaction with quality and accessibility, living standards, etc.
 - ✓ Discussion of the issue of creating a single environmental indicator vs inclusion of 4 separate indicators as a separate aspect
 - ✓ removing non-essential indicators
 - ✓ updating the rationale for indicators

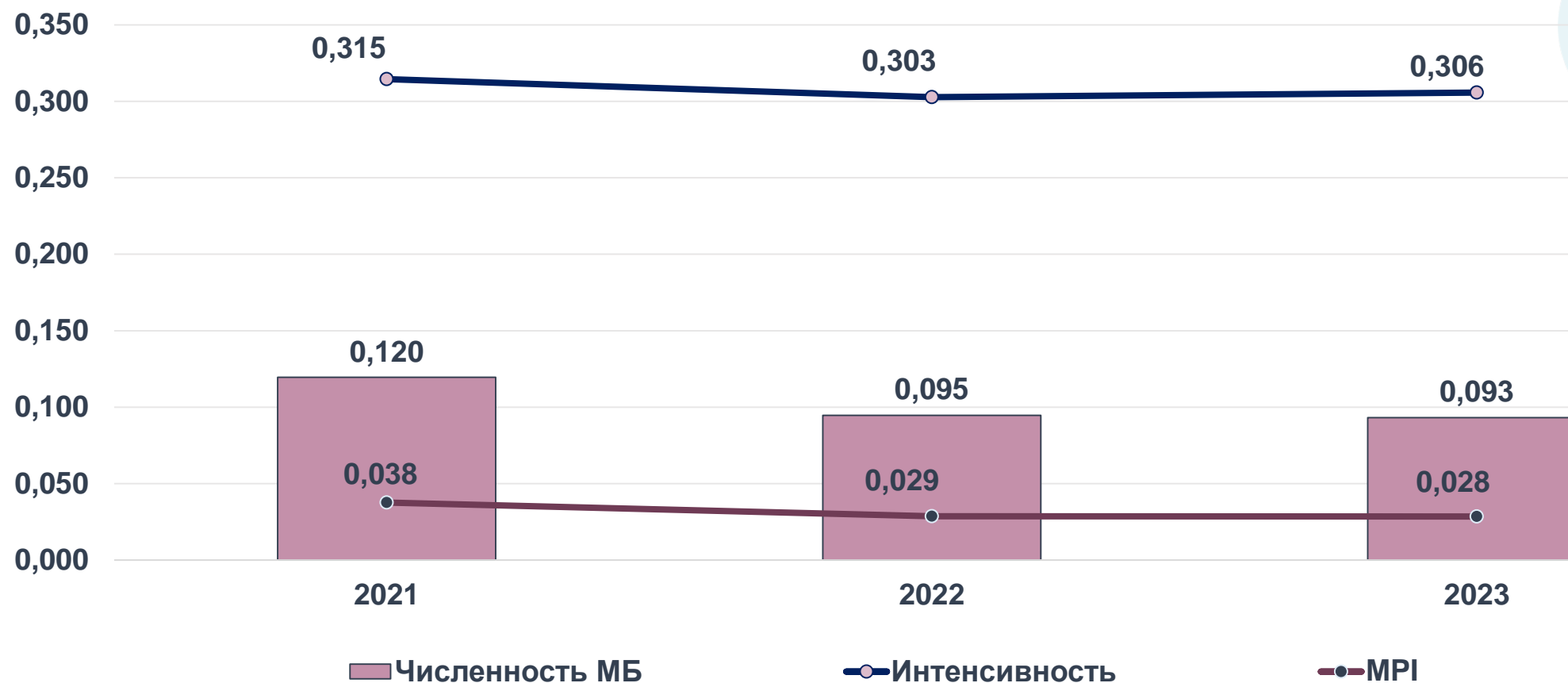

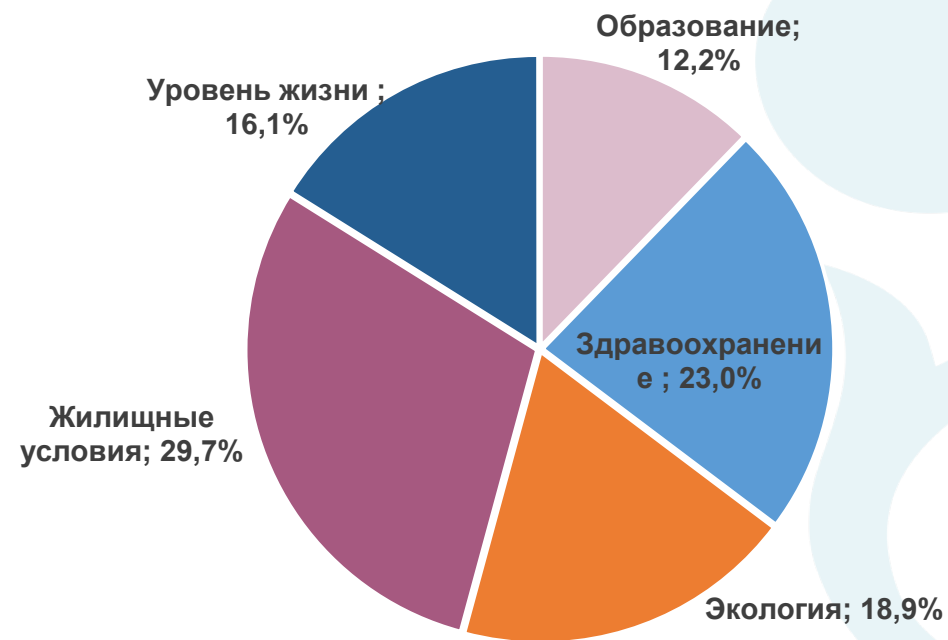
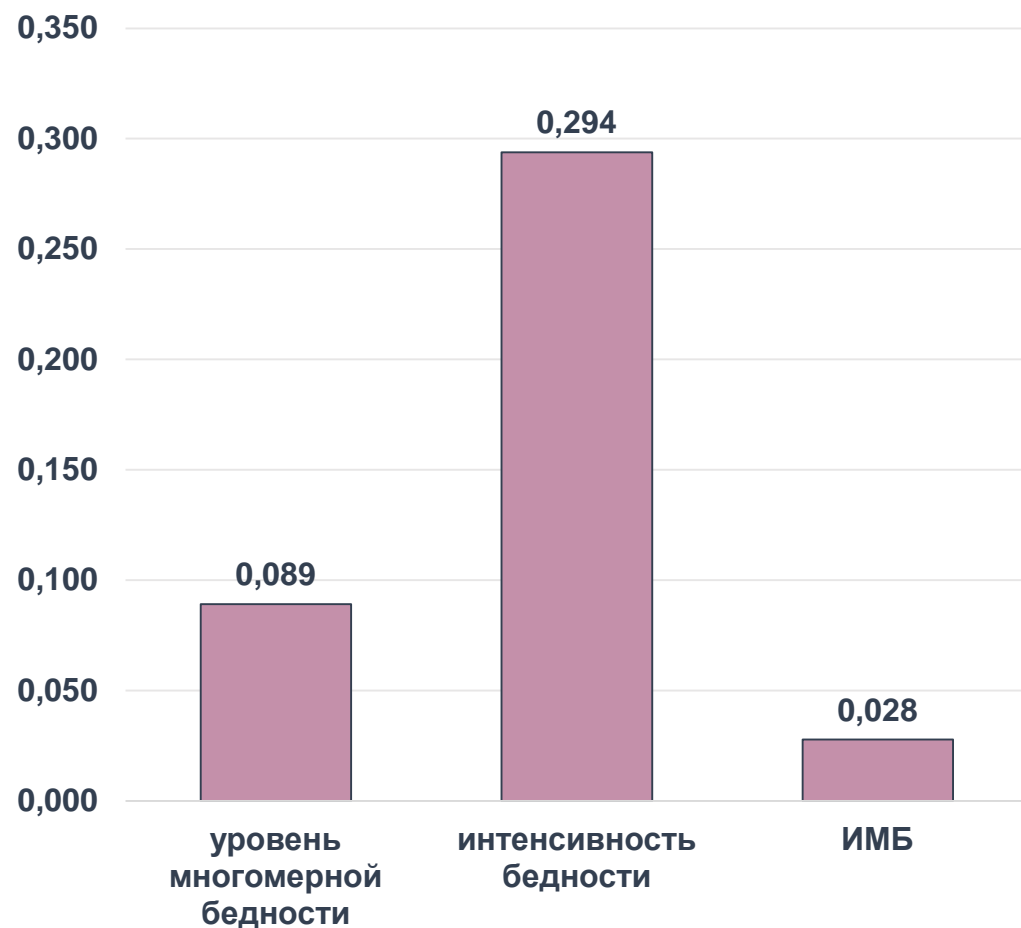
